

## Linguistic Model of application in the field of Education in the

## AUTONOMOUS REGION OF VALENCIA1

- Name of the language: Catalan/Valencian
- Status of the language: Official (named *Valencian* in the Statute of Autonomy of the Autonomous region of Valencia)
- Classification of the language according to the UNESCO: Not applicable
- Protected under the Charter for Regional or Minority Languages

## General description of the linguistic model of application in the territory

The language model of the Valencian education system is set by the Law 4/2018, of 21 February, on the Promotion of the Plurilingualism, which regulates and promotes plurilingualism in the Valencian educational system. All educational centers supported by public funds must apply the Multilingual and Intercultural Education Program (known in Catalan as Programa d'Educació Plurilingües i Intercultural -PEPLI) described in the aforementioned law.

This program (PEPLI) establishes that at least 25 % of class hours are taught in Valencian/Catalan and another 25% in Spanish, the official languages of the territory; besides, at least between 15% and 25% of class hours are taught in English. This rule applies in the whole formal education with the exception of universities.

Each school has its own set of regulations with regard to the remaining percentage of class hours, which can be taught in Catalan, Spanish, English or in a foreign language. This linguistic distribution must meet sociolinguistic criteria.

The key objective of the Law 4/2018 is to guarantee that all students achieve a multilingual competence at the end of the compulsory education: oral and written proficiency of Valencian/Catalan and Spanish; and functional proficiency of one or two foreign languages.

Under this heading, the Law 4/2018 -in line with the recommendations made by the public universities of the Autonomous region of Valencia- stablishes an optimum distribution percentage of class ours in order to meet the objectives set by the Law, which is estimated to be 50 % in Valencian/Catalan; 25 % in English and another 25% in Spanish language.
